**Important Information:** The LCMC Health Called-to-Care Nursing Scholars Program / Program Description and Recipient Agreement (the "Agreement") contains information about the Program including eligibility, program requirements, nonpayment, default, any required repayment, and the possibility and consequences of the forgiveness of the Liquidated Damages. All capital terms used herein shall have the meaning set forth in the Agreement.

Eligibility: In order to qualify for the Program, you must meet the following criteria:

- 1. Application, acceptance and commitment to the Degree Program at the University in Metropolitan New Orleans.
- 2. Eligibility for hire or rehire, as applicable, by LCMC Health.
- 3. Successful completion of the following screenings in accordance with Louisiana State Board of Nursing requirements:
  - (a) Criminal Background Check;
  - (b) Civil Background Check;
  - (c) Federal Officer of Inspector General Exclusions Database; and
  - (d) Louisiana Department of Health and Human Services Direct Service Worker Exclusions List.
- 4. Ability to physically attend Degree Program classes at the University in Metropolitan New Orleans.
- 5. Willingness to fulfill up to a three (3) year full-time employment commitment in a specified LCMC Health facility. The full details regarding the employment commitment are specified in the Agreement.
- 6. Participation in and/or completion of additional activities or requirements which may be specified by University as conditions of participation in accordance with the University's policies, disclosures, and student handbook.
- 7. Minimum age of 18 on the date of completing the Called-to-Care Scholars Program Application.

**Disbursement**: On a per session basis until the earlier of: (i) 38 months; (ii) graduation; or (iii) an Event of Default.

**Recipient's Financial Obligation:** Equal to the total Tuition payments made by LCMC Health to University on Recipient's behalf. Recipient's Financial Obligation, including interest, will be forgiven if Recipient fulfills the Work Commitment.

Fees: No fees are charged under this Program to you by LCMC Health.

**Cost Example:** Upon an Event of Default, the unforgiven/unpaid portion of Recipient's Financial Obligation shall be considered Liquidated Damages, shall be due and payable within twelve (12) months, and will carry a default interest rate of five percent (5%), compounded monthly.
